Dear *Sir/Madam,*

This Ministry has been providing financial assistance to States under the scheme of RGPSA, CB-PSA etc. over the years, broadly for enhancing the facilities for capacity building and training of Elected Representatives, Panchayat functionaries and other stakeholders connected with Panchayati Raj Institutions across the country. In the wake of the campaign of Gram Uday Se Bharat Uday, the concept of formulation of GPDPs for proper utilization of resources including funds under award of FFC received by Gram Panchayats (GPs). Therefore, it became necessary that apart from imparting training in normal course, the training institutions and SIRDs are also required to impart focussed training on the various aspects of formulation of Gram Panchayat Development Plan (GPDP) by GPs. As per information available with this Ministry GPDPs have been formulated by approximately 1.75 lakh GPs. With a view to track the status of achievement by States on all these aspects it has been decided that you may kindly instruct your concerned authorities to furnish the information of certain points immediately as below:-

- (i) The status of GPDP prepared upto 31.05.2017 and that for GPDPs prepared on a monthly basis upto 30.06.2017 and 31.07.2017 and similarly thereafter.
 - (ii) Details may be furnished about training calendars finalized, for basic training, refresher training, GPDP training at different levels e.g. State/ District/ Block/ GP/Sub GP for the year 2017-18. This information may be provided in consultation with SIRD concerned.
 - (iii) Information may be provided regarding number of training programmes organized at State/ District/ GP/ Sub GP level. Number of participants in each training programme and at each level may also be indicated. Presently, this information may be provided upto 31.05.2017 and subsequently this information may be provided by 10th of each month in respect of the data/information relating to previous month.
2. A separate proforma has been prepared by this Ministry for each of these points (as attached) and the information may be provided positively in the prescribed proforma.
 3. I shall be grateful if you could kindly look into the matter personally and direct your concerned authorities to send the above mention information well within the stipulated time.

4. As emphasized by the CEC of RGSA in their meeting held on 25/05/2017, all States may organize innovative training programmes for Sarpanches and Panchayat functionaries on the lines of programme organized by MoPR in Siri Fort during Dec, 2016. Every state is requested to organize at least one such training program before September, 2017 and inform the Ministry in this regard.
