2. States will be conferred awards for their exemplary performance in e-enablement of Panchayats. Panchayats will be conferred awards for their better performance in their Panchayats. Panchayati Raj Ministers of the States, Principal Secretaries/Secretaries of State Government Panchayati Raj, academicians and other dignitaries will attend the conference.

3. You are requested to depute a delegation of elected representatives consisting of all the three tiers of Panchayats (in the ratio of 1:2:3 for Zila Panchayat: Intermediate Panchayat: Gram Panchayat respectively) for the National Panchayati Raj Day. The delegation should include awardees under Panchayat Sashaktikaran Puraskar and Rashtriya Gaurav Gram Sabha Puraskar, as well as elected PRI representatives from SCs/STs and women categories. States/UTs not covered under any of the awards mentioned above should also send their delegation comprising of elected representatives and functionaries of PRIs. Local hospitality i/c boarding/lodging and local travels) will be provided. The tentative number of delegates from each State/UT to attend the event is indicated at **Annex**.

4. Details regarding TA/DA etc. are being sent separately. To-and-fro travel arrangements have to be done by the participating States/UTs. TA/ DA upto a specified amount will be reimbursed to the state on submission of details.
